Miller moved to approve the agenda as presented; Nielsen seconded. Unanimous ayes.

Reports were received by Princ Dearie and Supt Schueller.

Bierstedt moved to approve the consent agenda, including prior meeting minutes, financial reports, and bills; Nielsen seconded. Unanimous ayes.

Bierstedt moved to approve the North Union Preschool Handbook as presented; Miller seconded. Unanimous ayes.

Nielsen moved to approve the North Union Elementary Student Handbook as presented; Bierstedt seconded. Unanimous ayes.
